Please note that this is the Master Database, there is a separate worksheet in available database and link on our pending Web site for each category below. Some categories contain general and specific recommendations for selection of a vendor in that category.

Accountants-All or the majority of the firms included also complete costs reports required for SNF facilities, and the majority have experience in accounting for nonprofit operators.

Accreditation & Education-Includes schools for advanced degrees, continuing education, accreditation, training and industry publications.

Activities-Includes misc. activities requiring products, as well as Cable TV sources. Most activities only require a local supplier or vendor.

Admissions/Marketing-See Consultants as well for marketing support.

Appraisers-While all included are experienced in Senior Housing and/or Long Term Care, if your purpose in obtaining debt or equity, you will have to rely on the appraiser selected by your lender.

Architects-While there is no category for engineers, Architects can both offer suggestions in that regard as well as organize or lead the development team that includes all engineers.

NOTES Notes to Senior Consulting Vendor and Professional Database

- 1 (1) This "Master Database" contains subsections for various types of vendors, consultants and professionals that provide services or products to Long Term Care Providers (subacute, rehab, skilled and intermediate nursing facilities, Assisted Living Facilities and personal care facilities) and Senior Housing (Senior Housing, Independent Living, Congregate Care, CCRCs and retirement communities). Please refer to the Table of Contents of this Database to find the subsection that best meets your needs. Hereinafter, the term "vendor" is applied to companies that provide services or products to the industry, as well as consultants and professionals of all types as listed in the Table of Contents. There are almost 1400 vendors as of this date in the Database, and there are expected to be over 2,000 when finalized. The Master Database will also be made available with each of the categories in the Table of Contents in separate worksheets.

- 2 (2) The Database contains national vendors or regional vendors of substance, those that provide services in many states. However, there are vendors that do not disclose where they do business. If not noted, then the vendor is a national vendor or gives no indication on their Web site or through our research that it is not a national vendor. Regional Vendors or confirmed multi-state vendors are noted, with the defined states they do business if that information is confirmed or available. Vendors in a single state are not included, except those that have a substantial presence in that particular state or have demonstrated the resources and commitment to expand services either directly or through active involvement in national associations.

(3) In all cases, vendors were called to obtain added information if not on their Web site or if available, faxed a request for information. If they did not respond to a first request, there was at least a second request. If they did not respond to a second request, then more detailed contact information was not included in the Database. We are firm believers in customer service that includes both an option to respond electronically at the convenience of a busy manager and the ability to reach a human being via phone or fax. We believe that customers deserve multiple options to communicate the way that best suits them, not the vendor. In this regard, bigger is not always better, as it was more difficult to obtain contact information from larger vendors on average, which was also the case for contact information for software vendors, educational resources and consumer information sources for seniors.

- 3 (4) National, Regional or Single State Vendor or Professional Considerations
There are differing benefits and issues when considering a national, regional or local vendor, depending on the product or service. For example, a national Pharmacy Provider may provide the best pricing, although service may be an issue if they do not have a regional distribution center close by. Another example is an accountant needed for Medicaid cost report preparation, where State specific experience is important, and therefore a national or regional accountant included in the Accountant subsection or worksheet of this Database may not be the best candidate for operators in certain states.

(5) In consideration of a vendor providing a product versus services, their location should be less of a consideration. Many vendors that provide services or products that require little or no onsite servicing or support are worthy of consideration even if they currently do not provide products/services in your area, provided references of other operators in various other locations, vendor commitment, pricing, resident benefits and staff comfort level are all considered.

(6) Some products and services are available from local vendors, with either no value added from a larger vendor or better service from a local vendor. Two diverse examples would be hospice services or paging services, and hence, there are limited vendors of these types and others where local vendors are easily accessible.

(7) Many regional vendors do not include information on the states in which they do business on their Web site. In some cases we called to confirm, in other cases we listed the state(s) they provide services at a "minimum." As former operators, we have found that in some cases you can find a vendor with great experience and references that has not done business in your state, but will offer added value to your facility(ies). One example is Gentell and other vendors that manufacture and supply skincare products.

- 5 (8) Research included the sponsoring vendors from the largest associations in the industry, the American Health Care Association (www.ahca.org and www.ahcaconvention.org), the Association of Homes and Services for the Aging (www.aahsa.org) and the Assisted Living Federation of America (www.alfa.org), as well as many other much smaller national associations, trade and professional associations, and independent research of all services and categories. Research also included the all State Associations affiliated with AHCA, AAHSA and ALFA, as well as trade and professional associations.

Both www.ahca.org and www.aahsa.org provide links to most of their affiliated state members, which is an added resource for many vendors in single states nationwide. Some of the other State Web sites and resources have been researched, and some are pending as of this date. Furthermore, some trade and professional association Web sites and resources have been researched, and some area pending as of this date.

- 6 9) While many vendors offer different services or products, with few exceptions, they are not duplicated in separate subsections or worksheets unless SC has confirmed a dual focus, which includes National Energy Services, Healthcare Services Group, Huntleigh Healthcare, Smith & Nephew, Senior TV, Invacare, Kinetic Concepts, Inc., Professional Services, MasterCare Patient Equipment, Inc., Idea Mid-America, Entegra Procurement Services, Caregiver Management Systems, T.H.E. Medical, Briggs, Schryver Medical, Inc., MedaStat, Graham-Field Health Products,

In addition, several consultants and software vendors are included in subcategories such as SNF and ALF.

Sunrise Medical, HHA Services, Consensus, Kendall Laboratory are included in three categories.

- 7 With consolidation, there are either several national or smaller regional vendors, with pharmacy the best example, as OmniCare and PharMerica dominate the marketplace.
